SCCA Staff Commodore Tom Collins contributed the following article concerning the history and evolution of the Marina Cup.

Before Marina City was built, the Venice Yacht Club was a member of the SCCA. When we decided to add feeder rallies to our schedule, Venice Yacht Club hosted a rally which became a feeder to the Pritikin. I believe they used the Pinkerton Trophy for that event. Back then SCCA Staff Commodores Mel Lurie and Paul Leland were past commodores and active in Venice Yacht Club.

When the Marina City Club was built, the builders created the Marina Yacht Club. For a while, it was simply a commercial enterprise without any real yachting activities. Venice Yacht Club was failing and some of their active yachtsmen such as Mel Lurie, Syd Palley, and Bernie Scheinbaum joined Marina Yacht Club and worked to make it into a real yacht club. Mel Lurie was key in creating the *Marina Cup* rally and he also created the present Marina Cup.

Initially, the *Marina Cup* was only a Santa Monica Bay Power Fleet rally but was soon added to the SCCA schedule as a feeder to the Oakley. Upon Staff Commodore Syd Palley's passing, the Palley Team Trophy was added to the rally. When the Venice Yacht Club closed its facility, the membership of Venice Yacht Club merged with the Marina Yacht Club. The combined club was called the *Marina Venice Yacht Club* and operated out of the Marina City club complex.

The Venice Yacht Club Log Race was dropped and picked up by Cerritos Bahia Yacht Club. It has had a number of yacht club hosts since then.

Addendum added for 2009 change of sponsoring yacht club:

The *Marina Cup* rally, as of 2009, will be sponsored by Cabrillo Beach Yacht Club starting outside and between the Los Angeles and Long Beach harbor entrances area and finishing at Marina Del Rey. It now returns to becoming a feeder rally to the Pritikin rally.

Eligibility: -----All eligible members of SCCA member clubs and per SCCA Rules.

Points for: -----SCCA Spring Series, Top Ten, Bathke, First Year Racer, & NACA

Trophies: ----- Marina Cup Trophy, Syd Palley Team Trophy (see note), keeper trophies in accordance with SCCA rules.

(Note: Each club may enter one or more teams composed of three vessels each. No vessel may be on more than one team. Notify the scorer by cell phone or VHF radio of team member composition before commencing the rally.)

Rules: -----Use SCCA Rally Rules as amended Feb. 18th, 2015.

Logs: -----Use SCCA latest revision. The predicted log shall be sealed in an envelope and given to the observer prior to the start of the rally. Turn in the actual log with your clock to the scorer, Ken Griffing, on Loon's Call promptly after the rally but not later than 1300.

Observers:-----Family member OK per SCCA rules.

Berthing:-----For slips call DRYC Port Captain Pauline Dror @ 310-823-4664, sooner than later; first come, first served. Information needed will be skipper's name and boat name, overall length, beam, and draft.

Awards: -----Peel-Off and awards will be held at 1700 on the DRYC rear patio on Friday, April 27th, 2018. Following the PEEL-OFF and awards for the Marina Cup on Friday evening there will be an informal skippers' meeting for the PRITIKIN rally. Bring your Predicted Log form for the PRITIKIN rally to give to the Scorer for adjusted start times.

Dinner:-----Skipper's choice: DRYC dining room available or local restaurant.

Start:-----Range on LOS ANGELES LT FI G 15s 73ft 14M HORN & BreakWtr -- 50 yards starboard

WP-1:-----At skipper's choice between the Start and CP-1

CP-1:-----33° 41.5' N / 118° 17.0' W

WP-2:-----At skipper's choice between CP-1 and CP-2

CP-2:-----33° 44.0' N / 118° 28.0' W

WP-3:-----At skipper's choice between CP-2 and CP-3

CP-3:-----33° 47.5' N / 118° 28.0' W

WP-4:-----At skipper's choice between CP-3 and CP-4

CP-4:-----33° 51.0' N / 118° 28.0' W

WP-5:-----At skipper's choice between CP-4 and CP-5

CP-5:-----33° 54.4' N / 118° 28.0' W

WP-6:-----At skipper's choice between CP-5 and the Finish

Finish:-----Abeam FI R 6s 23ft 4M "2" at north end of Marina del Rey breakwater -----
----- 225 yards starboard

(Use caution when entering Marina del Rey due to dredging operations and traffic exiting from behind breakwater; north entrance MAY be closed due dredging necessitating using south entrance.)

Approximate official distance is 25.7 nautical miles:

Note 1:----- Use charts: 18746 – Ed. 40 corrected thru LNM 03/31/2018; 18749 – Ed. 44 corrected thru LNM 03/31/2018; 18744 – Ed. 33 corrected thru LNM 03/31/2018; 18748 – Ed. 1 corrected thru LNM 03/31/2018.

Note 2:----- Any and all equipment aboard the vessel may be used except that which is prohibited.

Note 3:----- Use of the following data from any source is prohibited:

a. Clock time or elapsed time.

b. **NO GPS SPEED INDICATION IS PERMITTED.** COVER ALL INDICATORS OF SPEED WITH OPAQUE TAPE.

Note 4: This contest WILL allow an Open Log during the rally. During the rally the skipper may have access to all times that were recorded on the Actual Log.

Note 5:----- NO penalty for start time differences.

Note 6:----- No handicap scoring will be used.

Note 7:----- Radio: Monitor VHF channel 71 for rally information; channel 16 for safety.

Note 8:----- Skippers may choose locations of Waypoints 1, 2, 3, 4, 5, & 6. Record WP times on reverse side of Actual Log.

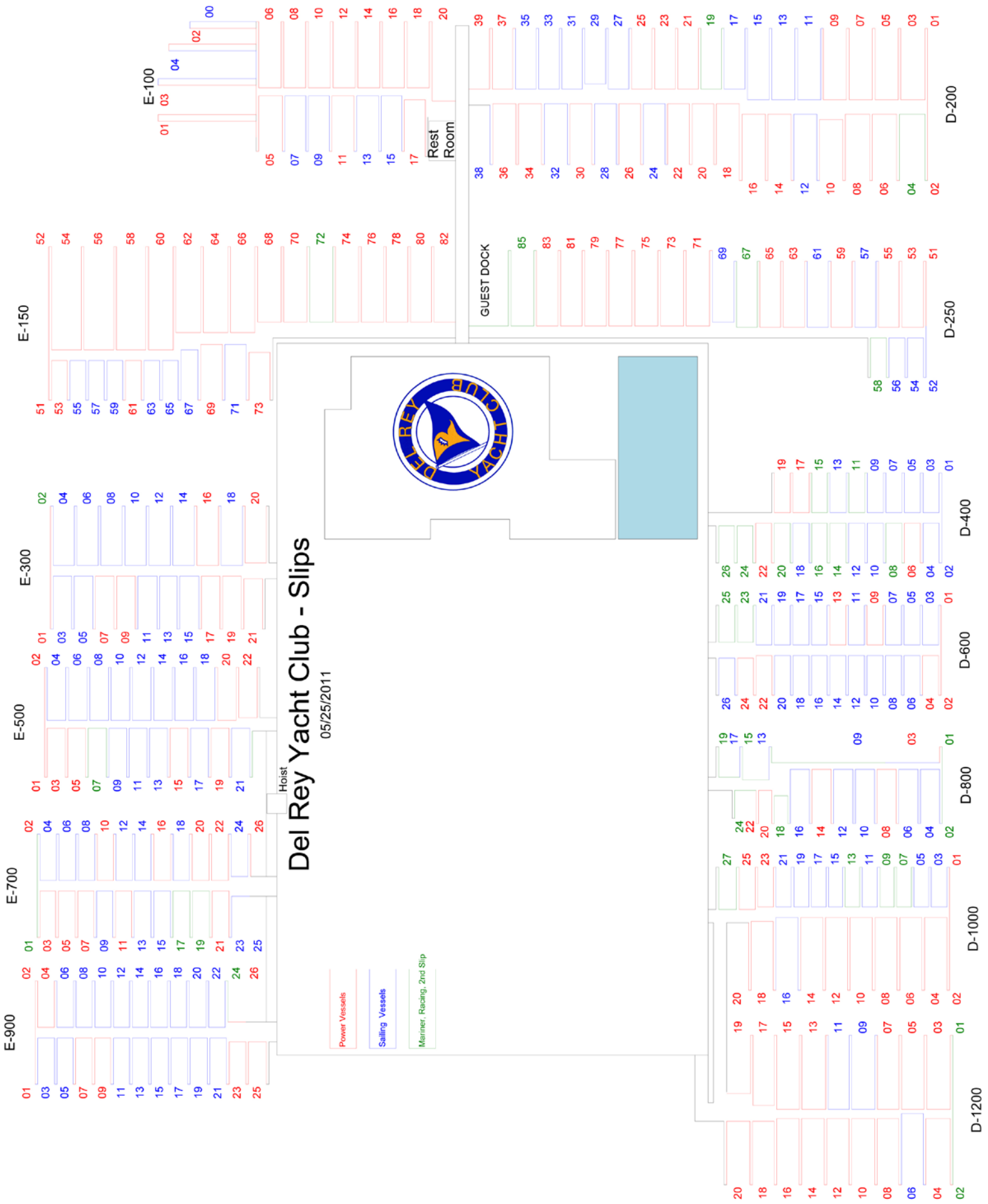

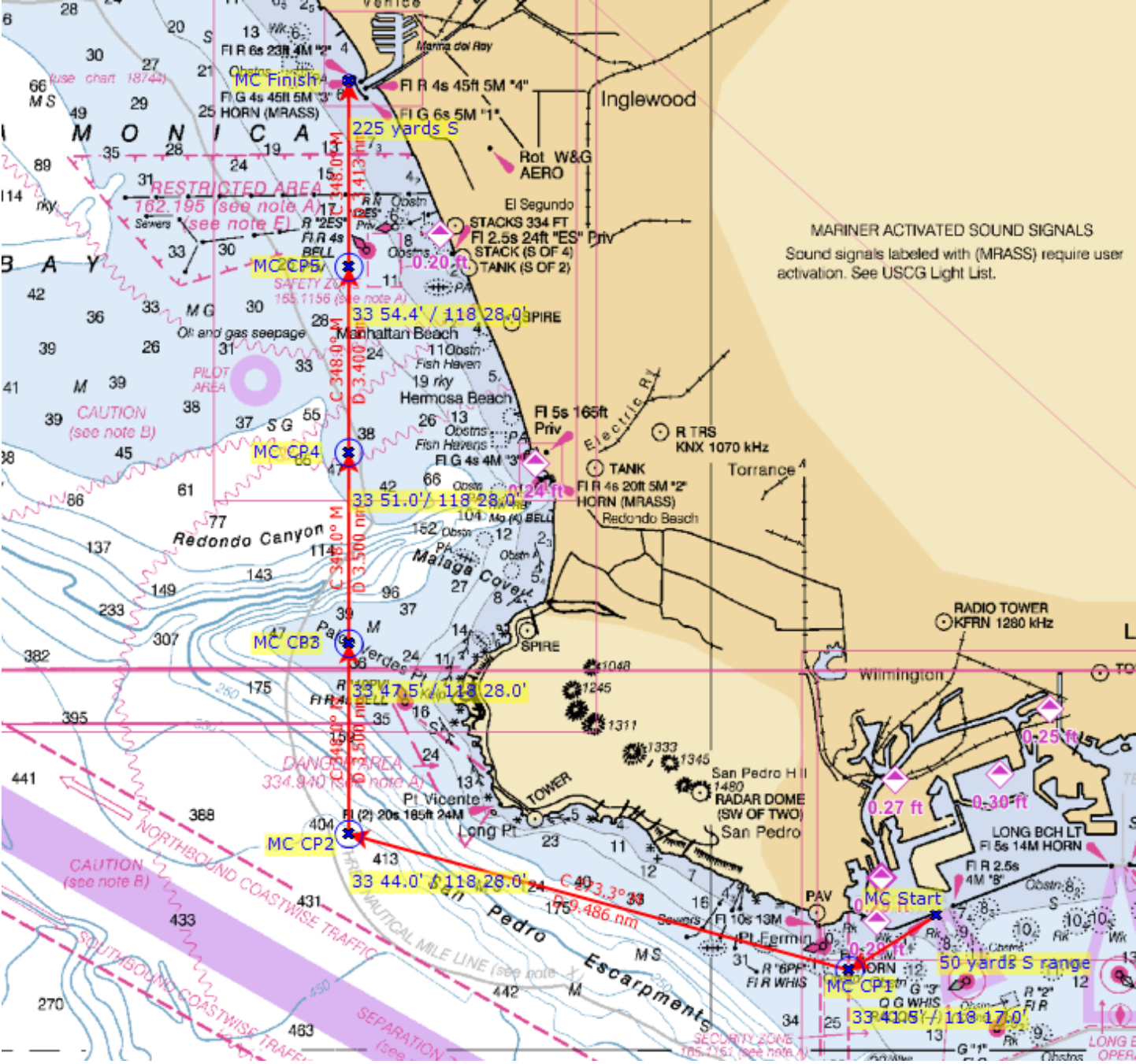
